Methods of processing, basic disposal facilities, disposal options, and the environmental issues of solid waste management will be covered in this course. In addition, this course provides the student with relevant information about municipal solid waste reduction and on hazardous waste management. This course is therefore an essential course for diploma programme in Environmental Engineering
