1.0 About Gujarat Technological University

The Gujarat Technological University (GTU) has been established by the Government of Gujarat vide the Gujarat Act No. 20 of 2007 in the year 2007, the objects of the University shall be to develop the knowledge of Science, Engineering, Technology, Management and Environment for the advancement of quality of life of the mankind in general and in relation to the domain of Engineering and Technological development and applications. The GTU is a Affiliating University and its jurisdiction is whole the state of Gujarat. All the colleges or institution imparting education in engineering, technological, pharmacy and management in the state of Gujarat are associated /affiliated with the Gujarat Technological University. 3.0 Scope of work

The Scope of work includes the following work and job to be done.

(1) Scope of work for convocation ceremony. (Event a)

Providing, errecting on hire charges of Dias, Stage, steel structure double height mandap, mandap dome of steel structure, screen, play wood flooring, stairs for stage, Ramp, decorative gates, red carpate, blue or green net flooring, VVIP roustam, coirmate carpate, plastic moulded chairs, chairs with cushion, sofa set, berricating by GI pipe/MS Pipe/aluminium chequred grill pipe to employee service personal for drinking water and sanitation services. Counter for buffet, mineral water for dignitaries for general public, disposable glass, chair cover of siphon cloth, VIP steel berricating, flag pipe, flags, wooden tipoi, Glass tipoi, leather sofa, Big size VIP bougy, VIIP bougy, Rose sticks, Sound stage, Decorative freel on dome, Fency natural flower pots, White clothe napkin, Fency tray, Good fregnance spray, Green room, VIP toilet, General toilet, Stage decoration with flowers, provindg sound system, Illumation by halogen, Pedestal type fan, DP, TP, TPN switches, Armoured cable, Heavy duty flood light, VLCP RCCB switches, Generator set, Dustbins, Q-Manager, Ciphon cloth flag with logo and selected colour, Digital video shooting with three high definition camera set up, led screen of 8ft by 10ft size screen for live telecast, lcd plazma tv for live telecast, 3 sets (per set 4 DVD) DVD making, Photography assignment for 2 professional cameraman, Colour 5" X 7" Size photographs. (2) Scope of work for Exhibition Stalls (about 100) along with mandap.(Event b)

After completion of convocation ceremony the same mandap is to be converted into stall arrangement. The scope of work includes providing, errcting by hire charges, steel structure mandap, decorative gate, Synthetic carpate in stall, PVC net flooring, laminated exhibition stall feeting aluminium section with name facia board, plastic moded chairs, counter stall, VIP toilets, Jute urinals, glass tipoi, lether sofa, sound system, helogel lightings, pedsteal fans, DP TP TPN switches, VLCP/RCCB Switches, Generator, Public address system, providing mineral water. Maintaince of katchha roads and parking area by sprinkling of water by water tanker etc. Keeping the expert operators throughout the programme so that all services remain functional without any interruption.

- (3) Preparation of plans and approval from competent authority well in advance before line out and execution for the events as above.
- (4) Getting the stage competency certificate from executive engineer for the events as above.
- (5) Getting the certificate from electric inspector of industrial department for temporary electrical installation for the events as above.
- (6) Electrical installation work shall have to be carried out by licensed electrical wiremen and engineers for the events as above.
- (7) Getting the temporary electrical power supply from torrent company for the events as above at appropriate place of events.

4.0 Objective:

The objective of the work is ceremony programme for GTU 2nd annual convocation and thereafter proposed exhibition showing the different outstanding work being carried out by the colleges, under college development council (CDC).

5.0 Important Matters Related to EOI.

The work includes the following two events.

- (a) Providing Mandap and decoration along with electrification, sound/PA system, furniture, LCD display, food courts, water supply, sanitation, etc. for 19th January, 2013 for the most prestigious event of Convocation 2013 for expected 10000 PAX expandable upto 13000 PAX.
- (b) Providing 100 stalls in the said mandap along with all necessary furniture, electrification for two days, i.e., 25th and 26th January, 2013 for the proposed exhibition under College Development Council (CDC).

- The bidder/firm must possess the requisite experience, strength and capabilities for providing the services necessary to meet the requirements, as described in the EOI document.
- 2. The applicant must also possess the technical know-how and the financial wherewithal that would be required to successfully provide the job sought by GTU.
- 3. The bids must be complete in all respect and should cover the entire scope of work as stipulated in the EOI document.
- 4. The invitation to bid is open to all who qualify the eligibility criteria as given below
- 5. Eligibility criteria are mandatory and any deviation in the same will attract bid disqualification.
- 6. The bidders/firm shall be a mandap/decoration service company doing the same work and having experience of providing services in convocation type function of any education institute/university.
- 7. The average turnover of the bidder/firm in the said field and activities shall not be less than Rs. 1 crores for the last financial year i.e 2011-2012 and shall have completed atleast one minimum job of such type costing about Rs.30 lacks in the current financial year i.e 1-4-2012 to 30-11-2012.
- 8. The bidder/firm shall be an Indian.
- 9. The bidder/firm shall have sufficient experienced professional/technical staff for conducting such work.
- 10. The Bidder should not be under a Declaration of Ineligibility or blacklisted with any of the Government/ Public sector unit Agencies/ University / educational institute / Board / Council.
