

# **Announcement of International Experience Program (IEP) 2017 at Kansas State University (KSU), USA for students of BE (EC/ET/Electronics, Electrical Engineering, Mechanical Engineering) studying in 6<sup>th</sup> semester**

*GTU's International Experience Program is by far, the largest internationalization program, amongst the universities in India. International Experience Program is one of the important components of the internationalization program along with Joint research and other academic collaborations with foreign universities exchange of students and Faculty Members.*

GTU is announcing its International Experience Program (IEP) for the 6<sup>th</sup> consecutive year as a part of its continuous journey towards becoming a truly global university. Under IEP, since 2011, GTU is sending students to Canada, USA, Russia and Germany in the months of June and July every year. During the period of 5<sup>th</sup> June 2016 to 5<sup>th</sup> August 2016 total 88 students had participated in IEP-2016 at Kansas State University.

GTU is inviting application from interested students for IEP -2017 at Kansas State University, USA. Please go through the information given below.

At KSU, the classes for these subjects will be held regularly for at least 8 weeks during the summer. The students have to appear in the midterm and final exam for the above courses at KSU, USA. Once student successfully studies the course and finishes all the required assessment at KSU, he/she will be back to his/her Parent College and finish their remaining subjects of the final year.

Upon successfully passing the exams at KSU, a student may be given subject waiver for the above mentioned subjects accordingly. A student, who passes the examinations for both the courses successfully at KSU, will be able to take two less subjects during the final year and will not have to retake these courses when he/she resumes his/her study back at his/her parent college. The institute may conduct extra classes/ lectures/ guidance sessions if required or requested by the students participated in IEP.

GTU will get VISA related papers from KSU for the selected students and then the students will be guided to apply for the VISA.

**Please note** that short listing does not guarantee the visa for a student, since every student has to fill up the visa application form and supply the necessary information to the Embassy in India. KSU and

GTU will help by recommending the names of the selected student to the US High Commission.

**Classes at KSU for the IEP will start during the second week of June 2017.**  
**A detailed time table and exact dates will be made available to the selected students.**

**Selection Criteria**

**1. Basic Criteria:**

- Students who are going to appear in the university exam of semester-6[BE- EC/ET/Electronics, Electrical Engineering, Mechanical Engineering] in summer-2017 can apply for the program.

**2. Academic Criteria:**

- Applicant's CPI/CGPA must be 5.0 and above till semester-5 for BE- EC/ET/Electronics, Electrical Engineering, Mechanical Engineering).
- Total backlog should not be more than 2 at the time of application and in this case minimum CPI/CGPA should be 5.5 .

On basis of above mentioned criteria, students will be selected to pay the confirmation fees on first come first serve basis according to their application date and time due to availability of limited seats.

- Once students are shortlisted as per the available seats they will be informed by **email only**. They are required to submit confirmation amount of ₹.10, 000/- (Rupees Ten Thousand Only), which will be reimbursed towards the final payment.
- **Please note: This amount will be nonrefundable in case if student withdraws from the program. In case, if student is not granted visa, the amount of ₹.10, 000/-(Rupees Ten Thousand) will be refunded after the program is finished.**
- **GTU reserves the right to withdraw or reject any application at any point of time without stating any reason.**
- **Please note: The visa fees and VFS charges (Sr. no: 5 in Table-2) are nonrefundable in case of non-granting of the visa or once it is paid to High Commission.**
- You will receive further instruction of the program procedure via **email** with necessary step by step procedure.
