#### **SELECTION PROCESS:**

- 1. Interested students shall register themselves for the internship on the following link.

  - A merit list shall be prepared by GTU after the registration is closed. Candidate selection will be done based on prepared merit list (highest CGPA to lowest CGPA)
- 2. The students shall receive an email for the same if they are selected for the further process.
- 3. If the selected students is not willing to join within the prescribed timeline, then the seat shall be passed on to the next eligible candidate.

#### TERMS AND CONDITIONS FOR STUDENTS AFTER JOINING THE INTERNSHIP

- 1. A fix pay of INR 9,000/- shall be paid to the selected students. No other allowances will be paid by the Employer to the interns.
- 2. Local candidates will be preferred for all locations. Subject to availability, transportation between the site and nearest town will be provided by GSPC.
- 3. This is strictly an Apprenticeship opportunity. The selected students will not be eligible to claim this internship as a permanent job.
- 4. Students should compulsory reside at nearby location during their internship period.
- 5. The students need to through all the conditions before applying.
- 6. The students who are engaged in this internship will have to behave in accordance with the rules, regulations and working hours of the corporation office.
- 7. Each student will have to submit the work report to GSPC during the Apprenticeship.
- 8. The performance of the student will be evaluated by GSPC.
- 9. The apprenticeship shall be terminated at any time without giving any notice for unsatisfactory performance or misconduct during the contract period.
- 10. On the completion of 1 year apprenticeship the student be awarded a certificate of Internship completion recognized by GSPC.
